Effective Immediately, The following policy outlines the eligibility, terms, and responsibilities for membership in the **Flower City Friends Club (FCFC)**.

1. Eligibility Criteria

To qualify for membership in FCFC, applicants must:

- Be **55 years of age or older and Reside within Brampton** or nearby areas.
- **Not hold membership** in any other senior or social club within Brampton or surrounding regions. And **Not hold an executive or board position** (President, Secretary, Director, etc.) in any other senior or social organization.

2. Membership Fees

- The **annual membership fee is \$15.00 per member**, or as determined by the Club from time to time.
- Members will be given **30 days' notice** of any change in fee structure. **Spouses are treated as separate members**, and individual fees apply to each.
- All payments must be made **via e-transfer to info@flowercityclub.ca**. **Cash payments are not accepted**, and fees are **non-refundable** once processed.

3 Membership Duration

- Membership is valid for **one calendar year**, from **January 1 to December 31**. All memberships **expire automatically on December 31** unless renewed. Renewal must be completed **before expiry** to maintain active status.

4. Application and Approval Process

- All applications are **subject to approval** by the **Board of Directors**.
- Applicants must be **referred by an existing member in good standing**. A **personal interview** may be required as part of the evaluation process.
- Successful applicants will receive a **one-year probationary membership**, after which full membership may be granted based on participation and compliance with Club policies.

5. Code of Conduct

- Members are expected to **uphold the values of friendship, respect, and community** at all times.
- Members must **follow all Club rules and policies** as established or amended by the Board.
- Any **misconduct or violation** of rules may result in **suspension or termination** of membership without refund.

6. Health and Safety

- Members are **personally responsible for their health, safety, and insurance coverage** while participating in any FCFC activity.
- Members requiring caretaker assistance must **make independent arrangements**. FCFC assumes **no liability for medical, health, or caretaker-related matters**.

7. Undertaking by Members

By applying for **new membership** or **renewing membership**, I hereby declare that:

- I will **adhere to all Club rules and regulations**, including any future updates approved by the Board of Directors.
